# I. Call to Order

SDR Chair Helen Wood called the meeting to order at 10:00 a.m.

# **II. Approval of Minutes**

Members approved the September 9th meeting minutes.

# III. Summary of Discussion

# A. Report from the SDR Chair

SDR Chair Helen Wood began by discussing the Disaster Roundtable at the National Academies scheduled for October 28<sup>th</sup>. Based on early registrations, record attendance is expected for the event. Helen reminded the members that the Roundtable will facilitate the sharing of thoughts and ideas, but will not result in recommendations.

Ms. Wood announced that she will provide two plenary presentations at the United Nations workshop on space programs in developing nations (Munich, Germany, 18 October). The presentations address integrated Earth observations for disaster reduction from the international (Global Earth Observation System of Systems) and national plan development (Interagency Working Group on Earth Observations) perspectives.

# **B.** Report from the NSTC Liaison

Dr. Gene Whitney announced that the National Earthquake Hazards Reduction Plan Bill (H.R. 2608) passed and that NIST was designated as the lead agency. An additional hazards reduction program for wind hazards was attached to the Bill, and Dr. Marburger may ask the SDR to facilitate.

Dr. Dennis Wenger expressed concerned that the Wind Hazards Reduction Program ignores critical feedback provided by SDR agencies and does not require social science research. Dr. Whitney recognized these concerns, but noted that the Subcommittee can address social science issues even though they are not directly mentioned in the bill. It is important to remember that though the Subcommittee addresses threats from an all-hazard terms, politicians think in specifics, hence the bill's focus on single hazards. It is appropriate for the Subcommittee to think broadly, while being prepared to apply specifically.

Dr. Whitney discussed the OSTP-OMB memorandum entitled "Updated Administration Research and Development Budget Priorities" which outlined the Administration's top priorities for the coming year. The document states that all agencies should be able to produce:

- 1. Definitions of all activities/programs.
- 2. An inventory of all programs in the baseline budget.

- 3. Agency tradeoffs to provide greater resources.
- 4. An interagency implementation plan.

Though disaster reduction is not mentioned in the Research and Development Priorities, we still must identify the key areas for investment in disaster reduction science and technology.

Dr. Marburger's statement on the International Day for Disasters has been approved with slight modifications and will be released on October 13 to the White House and NOAA press distribution lists as well as the SDR members.

# C. Grand Challenges

Grand Challenges Co-Chairs Priscilla Nelson and Noel Raufaste thanked all of the members for their feedback and comments on Grand Challenges drafts. They also referenced the upcoming clearance process, noting that there are several steps to clearance of the document; the Secretariat will provide details by October 15<sup>th</sup>. They also asked members to identify the three most important areas for investment in disaster reductions.

Dr. Earnest Paylor acknowledged the accomplishments to date and expressed concern about the focus of the document. He requested additional language reminding reminders that the Grand Challenges are part of a much bigger problem that cannot be solved by science and technology alone. Science is only part of the solution and must be combined with sound policy to work. Susan Conard agreed, adding that it is important that all of the challenges be written as scientific issues.

Dr. Gene Whitney said that the Grand Challenges will ultimately be implemented in agency budgets. There are two steps to this for each agency:

- 1. Look at the five year planning scope and agency priorities.
- 2. Examine the agency budget to see that they are meeting the national priorities.

The U.S. delegation will consist of about thirty members, lead by Deputy Assistant Secretary for State Mark Lagon.

Ms. Helen Wood announced that she accepted an invitation from the United Nations to chair one of the five themes for the conference.

### E. NASA Cooperative Agreement

Dr. Steven Ambrose announced NASA's Cooperative Agreement calling for proposals from all agencies to integrate NASA Earth science research results into applications of national priority. The solicitation is open to all organizations, private or public. The deadline for all responses is October 22<sup>nd</sup>.

# F. FY2005 Annual Operating Plan

A notional draft of the FY2005 Operating Plan was enclosed in the meeting packets and discussed very briefly. The Secretariat will redistribute copies to members by October 15<sup>th</sup> for comment.
