## I. Call to Order

National Science and Technology Council (NSTC) Liaison Dr. Gene Whitney called the meeting to order at 10:00 a.m.

## **II. Approval of Minutes and Review of Actions**

Members approved the December meeting minutes.

## **III. Summary of Discussion**

## A. Report from the NSTC Liaison

Dr. Whitney welcomed all new members to the Subcommittee on Disaster Reduction (SDR). New members were briefed about the structure, mission and history of the Subcommittee and the *Grand Challenges for Disaster Reduction*. The SDR does not micromanage agencies relative to disaster reduction, but instead makes policy and budget recommendations. The SDR recognizes the overlap between natural disasters and terrorism, and tries not to engage on national security issues. Dr. Whitney drew attention to the SDR PowerPoint handouts included in the meeting packets and recommended members visit the SDR website (www.sdr.gov) for further information.

## **B.** Report from the Chair

Ms. Helen Wood greeted new SDR members and thanked returning members for their continued dedication. Ms. Wood emphasized the essential interagency nature of the SDR and urged members to keep their agencies up-to-date about SDR activities before briefly reviewing SDR meeting procedures for the benefit of new members. She introduced the meeting packets, including the recently issued *Tsunami Risk Reduction for the United States: A Framework for Action*.

Ms. Wood pointed to the Tsunami Lessons Learned white paper as an example of work the SDR is often asked to do. The white paper served as an important framework for the tsunami national plan. All SDR reports and papers are currently posted on the website, and can be made available to members for distribution within their agencies by contacting the Secretariat.

Included in meeting packets was a letter from Ms. Wood to the member agencies asking for financial support for maintaining Secretariat support. The Secretariat is essential for moving SDR activities and actions forward. Any contribution from member agencies would be greatly appreciated.

Ms. Wood discussed the SDR's recent meeting with the White House Office of Management and Budget (OMB) to discuss the Grand Challenges for Disaster Reduction Implementation Plans currently in development. The OMB Examiners present at the meeting feel that the Implementation Plans will be useful and look forward to their publication.

The SDR Annual Plan has been completed for 2006 and the Secretariat will transmit it to the NSTC Committee on Environment and Natural Resources (CENR) for approval.

## C. Briefing and Discussion – National Science Board

Dr. Mike Crosby of the National Science Board (NSB) began his briefing by explaining that the NSB serves as the oversight body for the National Science Foundation (NSF) and also serves as an independent body of science advisors for the President. The NSB feels there are two important hurricane-related questions that have not been addressed:

- 1. To what extent does the Nation understand the science and engineering involved in hurricanes, and
- 2. How can this understanding be improved to reduce hurricane damages and improve warnings?

A public workshop will be held at NSF on January 24, with two follow up events on February 7 and April 18 and the Task Group on Hurricanes will solicit ideas from federal partners, academia and industry about how best to address these issues. The Task Group on Hurricanes expects to produce a report for the President this year. While that report will make some overall recommendations, it will mainly describe the potential role of NSF in moving the Nation forward. This exercise does not pertain to Hurricane Katrina in particular; it is an overall hurricane exercise.

Helen mentioned the possible ties between this exercise and the National Academy of Sciences (NAS) Disasters Roundtable on Hurricanes, the results of which are currently available on the Disasters Roundtable website. Dr. Crosby agreed and mentioned that the NSB is always in communication with the NAS. Ms. Wood also mentioned the upcoming WindHRP report from the SDR which will also tie into this exercise.

Dr. Crosby distributed handouts and materials to the members. The Secretariat will provide electronic copies to all SDR members.

## **D.** Clearance Process

Dr. Whitney reviewed the basic SDR clearance process with the members, emphasizing the importance of participating in all steps of the process, as the first distribution of the document to member agencies may be the only opportunity for agency representatives to comment. It is the representative's responsibility to make sure their agency clears the document technically. The steps to clearance are as follows:

- 1) Participate in drafting the document or provide comments on the document in development
- 2) SDR members approve the document from a technical perspective
- 3) CENR members approve the document from a political/policy perspective
- 4) All White House offices approve the document

It is important that all members thoroughly review documents in Stage 2 as they may not have additional opportunities. Once documents go forward to CENR and the White House, they are essentially "locked" and can no longer be edited by the SDR. This is a very time consuming process and the SDR cannot publish any material without clearance.

## **IV. Working Group Reports Grand Challenges Task Group.**

Ms. Wood discussed the Grand Challenges process and the ongoing development of the Implementation Plans. A Schedule of Clearances for those documents was distributed and Ms. Wood emphasized that these documents – all 15 of them – must be cleared and published by June.

SDR Members and Agencies who must contribute to individual Implantation Plans are identified in the Clearance Chart. The Secretariat will schedule and facilitate meetings over the next six weeks to gather additional input and ensure overall consistency and excellence of these documents.

Dr. Noel Raufaste, Co-Chair of the Grand Challenges Task Group, suggested new members familiarize themselves with all past publications listed on the SDR website and congratulated the members on the effort they have put into this project.

**WindHRP Working Group.** Mr. John Gaynor, Chair, stated that the WindHRP document has completed the review process and is in OMB clearance awaiting distribution to Congress. It will be made publicly available on the SDR website following transmittal to Congress.

**Earth Observations Working Group.** Mr. Steven Ambrose, Co-Chair, announced that the 24-Hour Waiver Recommendation was completed with great success. NOAA will attend the February meeting to give an update about how the Recommendation was used and their next steps.

The Working Group will hold its next meeting on January 23. The Secretariat will circulate a meeting announcement and agenda prior to the meeting.

Ms. Wood introduced Dr. Rosalind Helz, former Co-Chair of the Earth Observations Task Group. Dr. Helz discussed a series of tables that were generated following the 2003 Earth Observations Summit that state which classes of Earth observations data are needed for disaster reduction. These tables were the "guts" of SDR recommendations to USGEO and the Near Term Opportunities for Disaster Reduction. Dr. Helz has updated these tables and urged the SDR to post them on the SDR website as a technical reference document.

**International Working Group.** Dr. Fernando Echavarria, Co-Chair, reported that the new U.S. National Platform for Disaster Risk Reduction had been approved.

The next meeting of the International Working Group has not yet been scheduled.

#### V. Close and Next Actions

Ms. Wood reminded the members that the next Disasters Roundtable will be held on March 20 and the next SDR meeting will be held on February 2, 2006.

#### VI. Adjournment

The meeting adjourned at 12:00 p.m. EST.
