# I. Call to Order

SDR Vice-Chair David Applegate called the meeting to order at 10:00 a.m.

# **II.** Approval of Minutes and Review of Actions

Members approved the March meeting minutes.

## **III. Summary of Discussion**

### A. Report from the Vice-Chair

SDR Chair Helen Wood attended the Early Warnings Conference in Bonn on 27-30 March 2006 where she gave a presentation entitled, "Promoting Risk-Wise Behavior: An Integrated Strategy for Reducing Vulnerability and Improving Resiliency." While in Bonn, Ms. Wood briefed members of the World Bank Hazard Risk Management team and plans to meet with them in a more formal capacity next month. Additional information about the Early Warnings Conference can be found in the Promotion of Early Warning Newsletter, which is in the meeting folders.

Dr. Applegate announced that he will officially become SDR Chair at the September SDR meeting.

## **B.** Report from the NSTC Liaison

Dr. Gene Whitney heralded the completion of the Windstorm Impact Reduction Implementation Plan. The document has been cleared by the White House and transmitted to Congress. A copy of the report and transmittal letters are in the meeting folders. Members can request additional printed copies of the report by e-mailing the Secretariat (<u>ewallace@grs-solutions.com</u>). The report will be available on <u>www.sdr.gov</u> as of Monday, 10 April.

Dr. Whitney explained that the National Oceanic and Atmospheric Administration (NOAA) will be the first agency to chair the Interagency Working Group identified in the report. Any SDR members interested in participating in the Working Group should e-mail the Secretariat (<u>ewallace@grssolutions.com</u>). NOAA will convene the first meeting in June and will meet at least quarterly thereafter, reporting to the SDR once per year.

### C. Grand Challenges Implementation Plans and Next Initiatives

SDR Clearance on the Grand Challenges Implementation Plans was initiated on 5 April. Members have until Friday, 14 April to respond with their clearances, comments and edits. A Grand Challenges Implementation Plan Clearance Calendar was included in the meeting folders. Members were reminded that there is a very tight timeline for the clearance process in order to publish these documents by the end of June.

Dr. Applegate led a discussion about the next initiatives related to the *Grand Challenges for Disaster Reduction*.

**Recast the Next Big Disasters as a supplement to the Grand Challenges.** The Next Big Disaster scenarios address potential catastrophic events that have a reasonable likelihood of striking major urban areas in the U.S. over the next several decades. The hazards, earthquakes, hurricanes, volcanic eruption, tsunami and flood, are real. Each hazard scenario would be followed by a section about how the Grand Challenges for Disaster Reduction can be addressed to reduce the impact of these events and prevent them from becoming catastrophic. These are test cases to see if the S&T advances outlined in the Grand Challenges for Disaster reduction really would reduce risk. This supplement would be developed in April/May and enter the clearance process in June.

This effort would culminate in a fall cabinet briefing by Dr. Marburger and a follow-on half-day roundtable with appropriate senior representatives of SDR member agencies.

**Develop a tool for the Office of Management and Budget (OMB).** The SDR would develop a tool for OMB to assist the analysts in interpreting the Grand Challenges Implementation Plans. This effort would be initiated through a joint OMB/Office of Science and Technology (OSTP) memo to all SDR member agencies requesting information how agency program related to disaster reduction fared under PART and GPRA analysis. Also, the memo would request information about how the Grand Challenges have affected agency budgets. Based on that information, the SDR will prepare the tool over the summer and deliver it to OMB in August/September.

**Complete Grand Challenges four-page implementation plans for cross-cutting themes.** The SDR will complete four-page implementation plans on Early Warnings, Earth Observations, Infrastructure, etc. Dr. Noel Raufaste, NIST, suggested a half-day offsite on 13 June 2006 to brainstorm these themes. The SDR will begin to work on these documents in earnest this fall and they will enter the clearance process next spring.

**Develop Grand Challenges report card and self-assessment tool.** The Grand Challenges report card will serve as a national assessment of milestones and a way to measure how well the federal government is managing disaster risk. Simultaneously, the SDR will develop a self-assessment tool to be used at the state and local levels. Dr. Dan Sosin, CDC, commented that there are already self-assessment tools related to terrorism preparedness and the SDR may want to examine some of those models. Dr. Bruce Davis, DHS, said that DHS has examples.

Dr. David Simpson, University of Louisville, will present a briefing on Measuring Community Emergency Preparedness at the May SDR meeting. The Subcommittee will brainstorm this effort as part of the half-day offsite in June and begin developing the report cards and self-assessment tool this fall.

# **IV. Working Group Reports**

**Grand Challenges Task Group.** Dr. Applegate recognized Dr. Raufaste for his leadership in shepherding the Grand Challenges Implementation Plans to the clearance process. Dr. Raufaste encouraged members to be timely in their responses to the clearance request and be prepared to reach out within their own agencies and brief the content of these implementation plans upon publication.

**WindHRP Working Group.** Dr. John Gaynor, NOAA, was recognized for his leadership in developing the Windstorm Impact Reduction Implementation Plan. Dr. Gaynor again asked that members interested in participating in the Working Group e-mail the Secretariat (<u>ewallace@grssolutions.com</u> or 703-560-7448)

**Earth Observations Working Group.** Dr. Steve Ambrose, NASA, reported that he is following up with the U.S. Group on Earth Observations (USGEO) on the mid- and long-term opportunities.

**International Working Group.** Mr. Chris Rothfuss, Department of State, briefed the SDR about the State Department's position concerning the Disaster Management International Space Coordination Organization (DMISCO) on Mr. Ralph Braibanti's behalf. Mr. Rothfuss said that the State Department is not in favor of creating an other group for the sake of another group. Others in the international community; however, do not see any overlap between this activity and other ongoing international endeavors. Mr. Rothfuss specifically requested representatives from NOAA and USGS

be present at the Committee on the Peaceful Uses of Outer Space meeting in Vienna on 7-16 June 2006.

Dr. Applegate informed members that the UK Department for International Development (DFID) released a new Disaster Risk Reduction Policy Paper. The Policy provides a framework for DFID to integrate disaster risk reduction measures more effectively into its own work and strengthen the international system's capacity to manage disaster risks. The DFID press release was included in the meeting folders.

Also, Dr. Applegate reported that Ms. Wood submitted comments to the Department of State about Iran's proposed Disaster Management Center saying that the U.S. is usually supportive of regionally based disaster reduction efforts, especially those funded by the host country.

### V. Close and Next Actions

The Harvard Global Conference on Disaster Prevention is 26-28 April 2006. Announcements were included in the meeting folders.
