II. Summary of Discussion

A. Finalize Mission Statement

The group began by reviewing the mission statement and changing the white paper due date to January 2008. The Secretariat was tasked with finalizing the statement and including a more robust definition of "livestock". The mission statement will be presented to the Subcommittee on Disaster Reduction at the May meeting.

B. Discuss the Resources-Related Bullets in the Grand Challenges Implementation Plans

Group members reviewed the bullets culled from the Grand Challenges Implementation Plans that mentioned resource impacts. Through this discussion, members identified the following possible focus areas for the white paper.

Ann Russell suggested the white paper have a section on better understanding the underpinnings of ecosystem services and resilience. Andrew Gude requested a list of climate variables predicted to change due to global warming and asked how those could impact natural resources and the scope of natural disasters. Jan Thorman suggested the group leave out Technological disasters because of the myriad issues it would raise. Emily Wallace noted the recurring theme of appropriate/effective land use management in the Grand Challenges Implementation plans and suggested that could be an area of concentration. The group echoed that thought and felt that would lead nicely into a broader discussion about Grand Challenge #6. Ann Russell suggested we look for places to recommend a greater integration of the social and ecological sciences. Overall, the group agreed to stress the importance of Earth observations for land and water.

Members will review the Grand Challenges and Implementation Plans to offer any additional suggestions prior to the next meeting.
